Letter from the CEO

The Land Trust has many exciting accomplishments to celebrate this year, and several celebrations to accomplish!

We are pleased to announce a conservation easement on the historic Trubody Ranch south of Yountville. This 121-acre working vineyard property has come down through three generations to its current owners, Jeff and Mary Page. This easement, encompassing 94 acres of the property, enables the family to preserve the property for farming in perpetuity, as well as protecting its native riparian borders as wildlife corridors.

We have also completed our Proactive Land Protection Plan, which charts a course for determining which lands should be given emphasis in our land protection programs. New maps, highlighting important conservation values, are helping us identify the areas with agricultural value, including rangeland, scenic open space, and land with high biological diversity.



On the celebration front, please join us for some engaging and entertaining activities to honor Land Trust Month in June. Our Dine, Wine, Shop & Stay program is a fun and easy way to help raise much-needed funds—simply mention the Land Trust at participating businesses during June and a portion of their proceeds will be donated to the Trust. Whole Foods Market Napa has also selected the Land Trust for its Nickels for Nonprofits program, running April through July. We have two parties scheduled to thank our generous donors and gracious volunteers. And some of our most popular field trips are highlighted during this special month.

We're also celebrating the career of John Hoffnagle, the Land Trust's longtime Executive Director. After 24 years of service, John is leaving to become the Executive Director of the Oregon State Parks Foundation in Portland, Oregon. John was the Land Trust's first full-time employee, and under his leadership we completed more than 150 projects, protecting over 53,000 acres—more than 10 percent of Napa County. He leaves the Land Trust on a strong financial footing, with a core membership of over 1700 people and a dozen volunteer-driven committees involved in a myriad of projects. We cannot thank John enough for his dedication and leadership.

Preserve Spotlight: Audubon-Cheyney

This 120-acre parcel is located within the Howell Creek (Bell Creek) Canyon, contiguous with Napa Hospital property and near the Devil's Punchbowl. It was bequeathed by Bruchman R. Cheyney in 1991 to the National Audubon Society, who initially sought to sell it. But once the Land Trust began investigating the property, it became obvious that it had a very significant natural value and should not be sold for development. The Land Trust accepted ownership in 1992.

Meeting the Land Trust's mission of preserving land that protects water resources, this property is part of the City of St. Helena's Bell Canyon watershed. It also helps preserve biodiversity, protecting the only reported habitat in Napa County for water oozels (dippers), as well as habitat for Northern Spotted Owls. The site consists of chaparral on south-facing slopes and old-growth Douglas Fir/mixed hardwood on north-facing slopes, and also possesses a mature stand of mixed conifer forest and riparian vegetation.


5¢ at Whole Foods Helps Land Trust!

Conservation Easement for Historic Trubody Ranch

The Land Trust of Napa County is pleased to announce a conservation easement on the Trubody Ranch south of Yountville. This means the historic property will remain in agriculture in perpetuity. Located in the middle of the valley floor in the Oak Knoll District, this 121-acre working vineyard property, of which 94 acres are now protected, has come down through three generations to the current owners, Jeff and Mary Page. The property has well-established riparian cover and huge Valley Oaks. Dry Creek, which forms

the easement's southern boundary, is a safe haven to the coyotes, bobcats, hawks, owls and other wildlife that also call this land home.

“Our conservation easements with the Land Trust not only enable our family to preserve this property for farming in perpetuity, but to also preserve its native riparian borders as wildlife corridors,” says Jeff Page. “We have long admired the work of the Land Trust of Napa County as an important community-based and -supported resource for the longterm protection of our valley.”

Peter Joseph Callizo

Joe Callizo died December 14, 2011 at the age of 74. A native of Pope Valley, he graduated from UC Berkeley and later served in the U.S. Army as a dog trainer. Joe served on the board of the Land Trust of Napa County as well as many other local boards. As the longtime caretaker at the Land Trust's Wantrup Preserve, he participated in a 20-year-long restoration of Valley Oak Habitat—one of his proudest achievements. He planted more than 1,000 acorns, over 500 of which have germinated and thrived. A leading Napa County botanist, he enjoyed hosting and assisting graduate students and researchers, and was a frequent participant, lecturer and field trip leader for the Napa Valley Museum, Napa County Historical Society, California Native Plant Society, Sierra Club and more recently Preservation Napa Valley.

A celebration of Joe's life will be held May 20 at the Wantrup Preserve. Contributions in Joe's memory may be made to the Wantrup Preserve, Land Trust of Napa County, or the UC Davis-Pope Valley Scholarship Fund.

Maggie’s Peak

Hike Rating

DIFFICULTY	MILES	ELEVATION GAIN
E = Easy	<i>See hike description for mileage</i>	+ less than 1,000 ft (relatively flat)
M = Moderate		++ 1,000 to 2,000 ft (some uphill)
H = Hard		+++ 2,000 to 3,000 ft (lots of uphill)
S = Strenuous		++++ over 3,000 ft (steep)
V = Very Strenuous		

For example, **M-3mi-+** is a moderately difficult 3-mile hike with less than 1,000 ft elevation gain.
